I/We on behalf of ourselves and on behalf of our child, in consideration for participation in AYS activities, hereby release and forever discharge AYS, MDIHS, its agents, officers, representatives and volunteers from any and all liability arising out of, or in any way related to any AYS and/or MDIHS activities.
